Regulations and Expectations

Please read the following and sign, acknowledging your agreement.

- Vendor businesses must be **licensed by the State of Utah** and must provide proof of licensure to LiveDAYBREAK with their completed 2024 Daybreak Fiesta Festival Vendor Application application. Licenses must be present at each individual booth.
- Vendor agrees to **pay respective fees** for participation in this event. Payment of which shall be made by cash, a check to "LiveDAYBREAK", or over the phone. Once the vendor is approved for participation, this fee becomes non-refundable under every circumstance.
- Overhead tents must be secured by a minimum **20 lb. base weight per leg**.
- Vendors must supply their own display materials.
- Because the event runs after sunset, vendors are responsible for providing their own lighting for their tent.
- Vendor space decorations and exhibits shall conform to any and all fire regulations. Toxic materials may not be used.
- Power:
 - For vendors who applied, paid, and were approved for power, you will be provided access to **one** outlet.
 - No power strips of any kind are permitted
 - Extension cords will not be provided and are the sole responsibility of the vendor
 - Personal generators are permitted in designated areas of the event site
 - Vendors must disclose if intending to bring their own generator prior to the event date
 - We highly recommend using LED and battery power for smaller items (lights, fans, etc.)
- Vendors must clean up the entirety of their designated event space including removing all decorations, products, and trash at the conclusion of the event.
- Acceptance of this vendor application by LiveDAYBREAK does not in any way mean an endorsement of the Vendor's services or products by Daybreak. Vendor business agrees that it will not advertise its business using the "Daybreak" name in any way.



- Vendor may not sublet, assign, or apportion any portion of its assigned space to another entity.
- Vendor may not exceed its assigned space dimensions in any manner. No Vendor may advertise or distribute materials outside of the space dimensions assigned to them or interfere with traffic in or around the exhibit area. Vendors are welcome to secure more than one space.
- LiveDAYBREAK reserves the right to restrict and/or remove any Vendor at its discretion for any reason including, but not limited to: unprofessional behavior, solicitation beyond the assigned space, noise, objectionable method of operation, or any other reason that LiveDAYBREAK may deem as a violation of the terms of these Regulations. In the event of such removal or restriction, LiveDAYBREAK will not issue any refund for participation fees paid or cover expenses incurred as a result of said removal.
- These Regulations and Expectations become a part of the agreement between the Vendor and LiveDAYBREAK. All matters in question not covered by these Regulations and Expectations are subject to the discretion of LiveDAYBREAK and all decisions made shall be so binding on all parties affected by them, as in the case of these original Regulations and Expectations. Authority to enforce these Regulations and Expectations is given to the LiveDAYBREAK Community Council Director.
